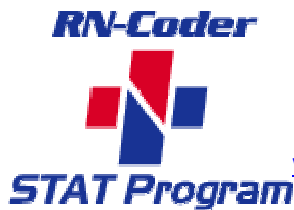

If necessary, we do the scanning, not your department. We can offer you savings of 20% or more off the rates of travel medical coders.

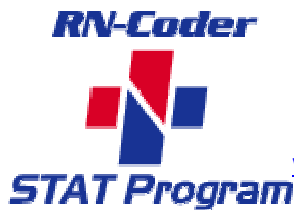
